Subscription Rates for 2024

In 2024, we will continue the **early-bird rate** for membership fees. If you pay your subscription before 1 January 2024, you will receive a discount on your membership fee. The early-bird rate is for both renewals and new members.

The price of subscription for 2024 has been set at:

- €42 for members in Europe (early-bird rate €38)
- €45 for members outside Europe (early-bird rate €41)
- €35 for members in Europe or outside Europe who have chosen to receive a digital Bulletin only

1. To your National Treasurer, if there is one in your country.
